NYS Legislature Passed Repeal of COVID Legal Protections: The New York State Senate has now passed legislation (**S.5177**) to repeal the COVID liability protections that were enacted in last year’s State Budget for physicians and other providers; the Assembly passed the “same-as” legislation (**A.3397**) recently. The bill will be sent to the Governor for his signature, but to date he has not announced whether he will sign or veto it.

We have urged the legislature to oppose A.3397/S.5177. These legal protections are still needed right now for the front-line health care workers who are managing New York’s thousands of new COVID cases – especially since we are seeing an increasing penetration of more easily spread variants. MSSNY had also warned that a court *could* possibly interpret S.5177/A.3397 to retroactively repeal liability protections for care rendered during the pandemic’s height in 2020, when there were no clear protocols for COVID treatment and many non-COVID services were required to be postponed. The general rule is that legislation is presumed to be applied prospectively unless there is clearly defined statutory intent to the contrary; and, in fact, several legislators did say they believed the repeal provisions would only apply prospectively. However, the issue of interpretation may still be open to debate, so please stay tuned for further updates.

Senate Passes Bill to Suspend 2% Medicare Cuts Through December 31, 2021: The Senate has expedited passage of a version of a House bill passed last week, which would extend the moratorium of 2% Medicare sequestration cuts through December 31, 2021. The House is expected to pass the Senate language when it returns from its recess in mid-April.

NOTE: All the Medicare Administrative Contractors (MACs), including National Government Services (NGS), have been instructed to **hold all claims with dates of service on or after April 1, 2021, for a short period.** (The Centers for Medicare/Medicaid Services (CMS) says the delay will be so short that it won’t affect providers’ cash flow, but you should still be aware of what’s going on.) According to CMS, “This will minimize the volume of claims the MACs must reprocess if Congress extends the suspension. [If necessary], the MACs will

automatically reprocess any claims [that have already been] paid with the reduction applied.”
